**THIS IS AN APPLICATION AND AGREEMENT FOR CREDIT AND SHALL APPLY TO ANY AND ALL CREDIT EXTENDED BY BATTLEFIELD GRAPHICS. THE CREDIT APPLICANT UNDERSTANDS AND AGREES TO THE FOLLOWING TERMS AND CONDITIONS OF SALE:**

1. TERMS OF SALE ARE NET 30 DAYS. AGENTS OF BATTLEFIELD GRAPHICS ARE NOT AUTHORIZED TO CHANGE OR ADJUST CREDIT TERMS WITHOUT AUTHORIZATION OF THE CREDIT MANAGER.
2. ALL CLAIMS AGAINST INVOICES MUST BE MADE WITHIN 5 DAYS AFTER RECEIPT OF GOODS.
3. ACCOUNTS NOT PAID BY DUE DATE ARE SUBJECT TO AN INTEREST CHARGE FROM DATE OF MATURITY AT THE RATE OF 1.5% PER MONTH (18% PER ANNUM) AS SHOWN ON INVOICES.
4. GOODS MAY NOT BE RETURNED WITHOUT PRIOR AUTHORIZATION OF BATTLEFIELD GRAPHICS.
5. GOODS/MERCHANDISE AUTHORIZED FOR RETURN WIL BE SUBJECT TO A MINIMUM 15% RESTOCKING CHARGE.
6. COPIES MADE FOR LOST OR MISPLACED INVOICES PROVIDED TO APPLICANT WILL BE SUBJECT TO A \$50 CHARGE
7. NSF CHEQUES WILL BE SUBJECT TO A \$100 CHARGE.
8. FAILURE TO COMPLY WITH THESE TERMS AND CONDITIONS MAY RESULT IN CANCELLATION OF CREDIT PRIVILEGES WITHOUT NOTICE. IN THE EVENT OF ANY DEFAULT, BATTLEFIELD GRAPHICS MAY (A) CLOSE THE ACCOUNT AND/OR (B) ACCELERATE PAYMENT OF THE FULL BALANCE.
